

Privacy Policy

Introduction

Vowed ("we," "us," or "our") is committed to protecting the privacy and personal information of our users ("you" or "your"). This Privacy Policy outlines how we collect, use, disclose, and safeguard your information when you visit our website [<https://vowed.in/>] (the "Site") and use our services (the "Service"). By accessing or using the Site or Service, you agree to this Privacy Policy.

1. Information We Collect

We may collect the following types of information from you:

1.1 Personal Information

1.2 Non-Personal Information

2. How We Use Your Information

We use the information we collect for the following purposes:

- To personalize your experience on our site and recommend vendors
- To send marketing emails and promotional offers (with your consent)
- To improve our site, content, and offerings based on your usage patterns
- To comply with legal obligations

3. Sharing Your Information

We may share your information with the following parties:

- **Vendors:** When you interact with or express interest in a vendor listed on Vowed, we may share your details with that vendor (such as name, contact information, and service requirements) to facilitate communication.
- **Service Providers:** We work with third-party service providers to help us operate our site and services, such as payment processors, hosting services, and analytics providers. These third parties will only use your information for the purposes we specify.
- **Legal Obligations:** We may disclose your information to comply with applicable laws, regulations, legal processes, or government requests.
